Pet Liability Release – Group Play / K-9 Daycamp / Shared Boarding**

**PLEASE READ CAREFULLY:** I, (please print) \_\_\_\_\_, have asked that my pet (s), \_\_\_\_\_, be allowed to interact (play) with, other pets during his/her boarding stay or Day Camp Sessions. I understand that Holiday Pet Hotel cannot guarantee that no harm will come to my pet(s) during these sessions and I will not hold HPH financially responsible for any injury or illness my pet(s) may sustain from these sessions. I am aware of the following and understand the conditions and possible liabilities of group participation:

- Camp is a very active, outdoor, multiple dog session which may last up to 2 hours at a time
- Dogs play with their mouths and paws which may cause a nip or tear to noses, ears, etc.
- Dogs may jump, twist, slide, fall or run into objects such as fencing or other dogs
- Dog owners represent that their dogs are healthy and have not been exposed to communicable diseases; but the in and out nature of Camp dogs makes this issue uncontrollable
- Camp dogs should not have fleas or ticks and owners agree to maintain their dogs on a systemic flea/tick control product such as Frontline Plus while enrolled in DayCamp
- All Camp dogs as well as boarding dogs must be currently vaccinated
- Dogs are pre-evaluated for Camp, however HPH cannot be responsible for changes in temperament or behavior
- Pet owners are responsible for informing HPH if they notice negative changes in their pet's behavior while enrolled in camp (we like to hear the positive too!)
- Camp Dog owners may be held personally liable for all damages, medical and otherwise, if their pet cause bodily injury to another dog during sessions
